### ECONOMIC SECURITY

At \$50,609, the median household income was slightly higher than the state median of \$49,698.

Participation in School Meals Programs grew by 16% between 2000 and 2007, from 24.8% to 28.8%.

1 child in 7 received Food Stamp benefits, about the same as the state average.

Rates of Food Stamp enrollments and students approved for School Meals have both increased since 2000—which may be related to increased child poverty as well as improved outreach.

41.9% of the county's child population is enrolled in Dr. Dynasaur/Medicaid, slightly less than the state average of 43.4%.

With the exception of poverty and median income estimates, all rates and counts are based on three-year averages. For example, the year 2007 represents the average of 2005-2007.

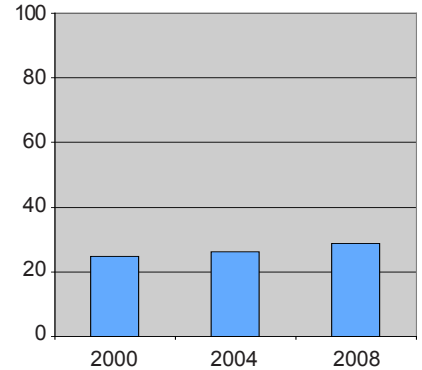

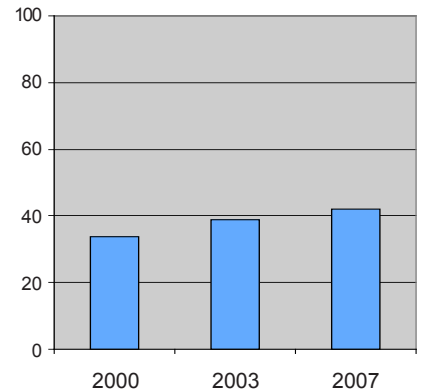

Percent of Students Approved for Federal School Meals

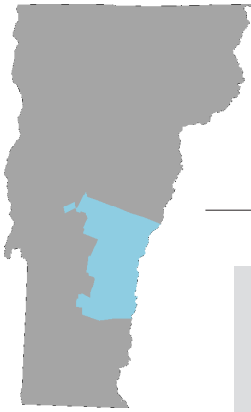


Percent of Children Enrolled in Dr. Dynasaur/Medicaid

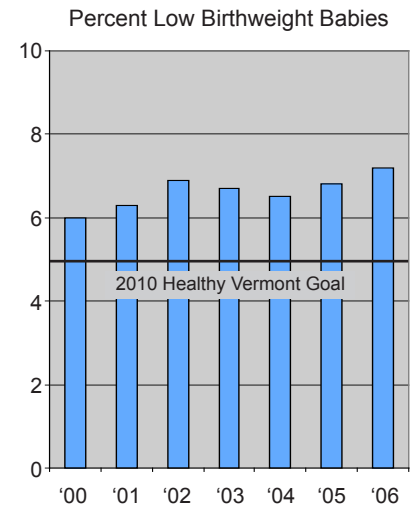

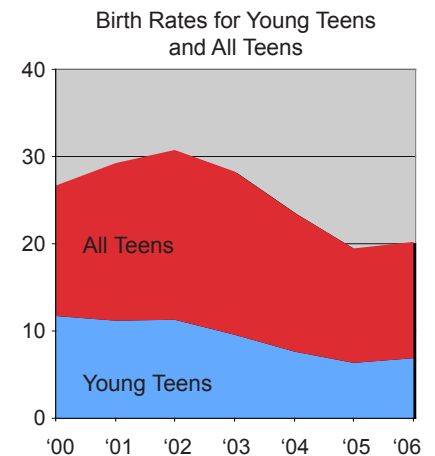
### HEALTH

Between 2000 and 2007, the number of children in Windsor County declined by 12%. The state child population also declined, by 11%.

Babies with low birth weight—under 5.5 pounds—are at risk of respiratory conditions, cognitive and developmental delays, and long-term conditions. In Vermont and nationwide, this problem has been increasing steadily. The Healthy Vermonters 2010 objective is to reduce the percentage to 5.0%. The county's rate increased to 7.2% of all live births, up from 6.0% in 2000.

Teen birth rates were 20.2 per 1,000 teen girls aged 15-19, which is about 24% lower than in 2000.

The percent of pregnant women receiving prenatal care within the first trimester was 83.8%, compared to the Healthy Vermonters 2010 objective of 90%.

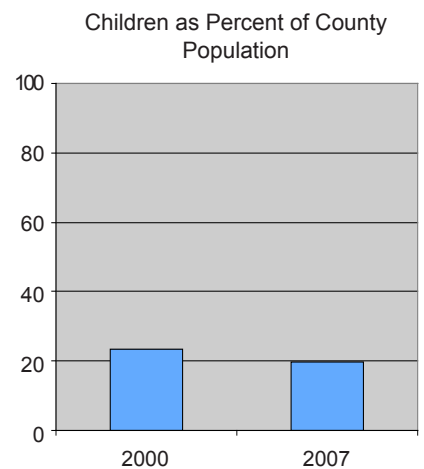


All health rates and counts are based on three-year averages. For example, the year 2006 represents the average of 2004-2006. Rates based on small counts should be used with caution. Such rates may change significantly from one period to the next—even if the actual count only increased from 1 to 2.

- 2 Pregnant women who seek early prenatal care (within first trimester), per 100 live births.
- 3 Infants weighing less than 5.5 pounds at birth per 100 live births.
